- The candidate will have to provide any one of Photo Identity Documents viz. **Aadhaar Card/Voter ID Card/Driving License/PAN Card/ any government authorized Photo Identity Document.** They will have to carry the same ID card in original along with the admit card to the examination centre, failing which they shall not be allowed to appear in the examination. The particulars of candidate such as name, father name etc indicated in Photo Identity Documents of candidates should match with admit card of the candidate issued by the Board.
- The candidate shall clearly indicate their preference of post(s) as well as Department/Office while filling through online application. Candidates will be allowed to mark their preference only against the vacancies for which they are eligible as per the details provided in the application form and the eligibility criteria mentioned in this advertisement. Applicants are advised to carefully think and indicate their order of preference. Preference once submitted shall be deemed final and under no circumstances will the candidates be allowed to change their order of preference at later stage. The merit list of the candidate shall be determined as per order of preference indicated by the candidate for particular post(s).

1. EXAMINATION FEES AND MODE OF PAYMENT:

- i. A Non-Refundable Fee of ₹ 150 for APST candidates and ₹ 200 for GENERAL candidates (to be paid online only).
- ii. Persons with Disabilities (PwD) are exempt from paying the fees.

2. ELIGIBILITY CRITERIA

- i. The candidate must be a citizen of India.
- ii. **The educational qualification, age, experience as stipulated in the advertisement shall be determined as on the closing date of submission of application.**
- iii. The vacancy for APST against the District Offices (**Post code 73/21**) is reserved only for the APST candidates who are domicile of that particular district as notified vide OM No. AR-47/10 dated 2/6/2011. Such APST candidate should be a PRC holder of that particular District.
- iv. The vacancies in the unreserved category shall be open to all as per above Govt. notification.

3. SCHEME OF EXAMINATION:

The scheme of examination will consist of two stages against posts indicated below:

Only Stage-1:

- Agriculture Field Assistant (Jr.) (Code: No.76/21)
- Laboratory Assistant (Code:No.77/21)



Both Stage-1 and Stage-2:

- Lower Division Clerk (Code: No.73/21, 74/21) and Data Entry Operator (Code: No.74/21)
- JSA (Code: No.75/21)
- Record Keeper/Record Clerk/Computer Operator (Code: No.78/21)

Stage- 1 (Objective Type Multiple Choice Questions) 300 Marks:

The test will comprise of the following subjects:

- (a) General English – 100 marks (50 questions of 2 marks each)

Syllabus:-Spot the Error, Fill in the Blanks, Synonyms/ Homonyms, Antonyms, Spellings/ Detecting mis-spelt words, Idioms & Phrases, One word substitution, Improvement of Sentences, Active/ Passive Voice of Verbs, Conversion into Direct/ Indirect narration, Shuffling of Sentence parts, Shuffling of Sentences in a passage, Cloze Passage, Comprehension Passage.

- (b) Elementary Math - 100 marks (50 questions of 2 marks each)

Syllabus:-i) Number Systems: Computation of Whole Number, Decimal and Fractions, Relationship between numbers.

ii) Fundamental arithmetical operations: Percentages, Ratio and Proportion, Square roots, Averages, Interest (Simple and Compound), Profit and Loss, Discount, Partnership Business, Mixture and Allegation, Time and distance, Time and work.

iii) Algebra: Basic algebraic identities of School Algebra and Elementary surds (simple problems) and Graphs of Linear Equations.

iv) Geometry: Familiarity with elementary geometric figures and facts: Triangle and its various kinds of centres, Congruence and similarity of triangles, Circle and its chords, tangents, angles subtended by chords of a circle, common tangents to two or more circles.

v) Mensuration: Triangle, Quadrilaterals, Regular Polygons, Circle, Right Prism, Right Circular Cone, Right Circular Cylinder, Sphere, Hemispheres, Rectangular Parallelepiped, Regular Right Pyramid with triangular or square Base.

vi) Trigonometry: Trigonometry, Trigonometric ratios, Complementary angles, Height and distances (simple problems only) Standard Identities like $\sin^2\theta + \cos^2\theta = 1$ etc.

vii) Statistical Charts: Use of Tables and Graphs: Histogram, Frequency polygon, Bar-diagram, Pie-chart.

viii) General Intelligence: It would include questions of both verbal and nonverbal type. The test will include questions on Semantic Analogy, Symbolic operations, Symbolic/ Number Analogy, Trends, Figural Analogy, Space Orientation, Semantic Classification, Venn Diagrams, Symbolic/ Number Classification, Drawing inferences, Figural Classification, Punched hole/ pattern-folding & unfolding, Semantic Series, Figural Pattern-folding and completion, Number Series, Embedded figures, Figural Series, Critical Thinking, Problem Solving, Emotional Intelligence, Word Building, Social Intelligence, Coding and de-coding, Other subtopics, if any Numerical operations.

(c) General Knowledge – 100 marks (50 questions of 2 marks each)

Syllabus: Questions are designed to test the candidate's general awareness of the environment around him and its application to society. Questions are also designed to test knowledge of current events and of such matters of everyday observation and experience in their scientific aspect as may be expected of an educated person. The test will also include questions relating to India and its neighboring countries especially pertaining to History, Culture, Geography, Economic Scene, General policy and scientific research.

- The test will be of Objective Type Multiple Choice Questions comprising of 150 questions as mentioned above. Each question will carry 02(two) marks. The candidate will have to complete the test in 03(three) hours.
- A candidate must secure a minimum of 33% or more marks in each subject in the written examination paper and must secure 45% of marks out of aggregate total marks in the written examination paper. The candidate securing less than 33% of marks in any of the subject shall be deemed not eligible for selection. There is no negative marking.
- The total number of candidates shortlisted for Stage 2 (Skill Test) will be in 1:3 ratio i.e if total vacancies are 10 then 30 candidates will be shortlisted for Stage 2.

Stage- 2 (Skill Test):

A Skill Test of qualifying nature will be conducted comprising of the following:

1. Typing Test

Typing Speed test of 35 words per minute on computer (35 words per minute corresponds to 10500 Key Depression per hour) (KDPH) on an average of 5 Key Depression for each word.



2. Basic Computer Application (50 marks)

- a. Word processing (Microsoft word)
- b. Spreadsheets (Microsoft excel)
- c. Slides (Microsoft powerpoint)

The candidate will have to secure at least 33% (16.5 marks) in aggregate to qualify the Basic Computer Application Test.

Note:

- Only the shortlisted candidates from Stage-1 as per the prescribed ratio will be allowed to appear for Stage-2 i.e. Skill Test.
- **Skill Test will be of Qualifying nature only, the marks secured will not be counted for preparation of the final Merit.**
- **The candidate must Qualify in Stage-2.**
- Other details, if any, of Skill Test will be informed in the official website.
- **Stage-2 (Skill Test) of the examination is not applicable for candidates for the post of Agriculture Field Assistant (Jr.) (76/21) and Laboratory Assistant (77/21).**
- The Final merit for all the posts shall be prepared on the basis of marks secured in written examination only.
