3. The shortlisted candidates will also have to mandatorily upload their documents and mark their preference for the post and department by logging into the website [www.apssb.nic.in](http://www.apssb.nic.in) using their credentials from 07-08-2021 (06:00 pm) till 11-08-2021 (03:00 pm).

4. 1 vacancy under Sports Quota for Junior Estimator of Deptt of UD & Housing is not included in this result. Only the eligible candidates under Sports Quota shall be considered for that vacancy. The recruitment under Sports Quota shall be conducted in due course of time as per the Govt. norms and guidelines. However, these candidates are eligible to be considered for the remaining non-Sports Quota vacancies on the basis of merit.

5. The allocation of post and department shall be done after document verification based on eligibility and merit-cum-preference. Provisionally selected candidates shall be allotted departments only as per the preferences indicated. Failure to upload documents and/or mark preferences shall result in rejection of candidature and non-allotment to any post.



6. The candidature of all the shortlisted candidates is PROVISIONAL subject to eligibility in all respects as prescribed in the Advertisement and Recruitment Rules. The candidates would be required to produce the original certificates in support of their claim relating to age, educational qualifications, category etc.

7. The document verification for shortlisted candidates shall be conducted on 13-08-2021 at the Office of APSSB, C-Sector, Itanagar from 10:30 hrs onwards. Please visit the website [www.apssb.nic.in](http://www.apssb.nic.in) to see the list of documents required.

8. *Candidates must note that their Candidature is purely provisional at this stage and their appointment will be subject to their name figuring in the provisional Select list which shall be prepared after the Document verification. Apart from that, they should fulfill the eligibility criteria as per Advertisement No. 08/2019 dated 18.12.19 and Corrigendum dated 19.12.19 including possession of the requisite documents, failing which their Candidature may be summarily rejected at any stage.*

9. *Further, the Appointing Authority i.e., the indenting/user department verifies the character and antecedents of the candidates, authenticity of documents/certificates and eligibility as per the Recruitment Rules before finally appointing the candidate(s). Therefore, the provisional shortlisting of a candidate does not confer upon him/her any right of appointment unless the Appointing Authority is satisfied, after such inquiry as may be considered necessary, that the candidate is suitable in all respects for appointment to the post.*
