PRESS RELEASE

This is General instruction to all the candidates appearing in LDC/JSA/Store Keeper/ Stock man etc. examination. All arrangements for this examination to be held on 21/03/2021 have been done by the Arunachal Pradesh Staff Selection Board. The examination is being held across 11 District and 61 exam centres wherein 25,731 candidates had applied out of which more than 12,000 candidates have downloaded their admit card till now. 14 Observers, 18 Coordinators, 11 District Superintendent (Deputy Commissioner), 11 Nodal Officers, 68 Centre Superintendent and 2426 Invigilators have been designated by the Board, in addition to Executive Magistrates and Flying Squads to ensure that exam is conducted in the manner which is fair, transparent and based on merit.

Further, adequate security arrangements have been done at all exam centres including deployment of male and female Police Personnel for frisking of candidates. Apart from that, adequate measures will be in place on the day of examination to thwart any attempt of impersonation, malpractices, cheating etc. Use of any electronic gadgets including mobile phones by the candidates as well as exam functionaries is strictly prohibited during the examination.

Candidates are also informed that their bio-metric data shall be captured on the day of examination and hence, they are instructed to come well in advance and do not rush-up at the last moment as no person shall be allowed to enter examination hall without their bio-metric data being captured at the entrance gate. Further, no candidate shall be allowed to enter examination hall premises after 09:30 AM.

It is also warned that if any candidate is found involved in any acts of impersonation or malpractices then he/she shall not be allowed to write the exam and FIR shall be lodged against him/her. Such candidates shall be immediately handed-over to the Police and shall also be debarred from appearing in all future examinations conducted by Arunachal Pradesh Staff Selection Board
