APSSB had notified vacancies for the post of Junior Estimator / Draughtsman (Gr-III) and Surveyor. Details of examination and application received, verified and appeared are as follows:

Additionally, one post each has been reserved for Meritorious Sports Persons (MSP) for both posts. However, the Board has deferred the recruitment to meritorious sports persons in accordance with instruction issued by Govt. vide DS/Sportsquota/2019/08 dated 11/3/2021.

The examination for the post of Junior Estimator / Draughtsman (Gr-III) and Surveyor was conducted on 17/07/2021 and 18/07/2021 respectively by Arunachal Pradesh Staff Selection Board. The examination was conducted at 3 venues. In order to ensure that the exam is conducted in the manner which is fair, transparent and based on merit, the Board had designated 2 Observers, 1 District Superintendent (Deputy Commissioner), 1 Nodal Officer, 3 Centre Superintendent and 143 Invigilators in addition to Executive Magistrates and Flying Squads.

Further, security arrangement was made at all exam venues including deployment of male and female police personnel for frisking of candidates. Use of any electronic gadgets including mobile phones by the candidates as well as exam functionaries was strictly prohibited during the examination. All precautionary measures as per covid-19 SOPs was taken by Centre Superintendents.



During examination, one female candidate Ms. Takoni Dodum was caught using mobile phone at the D.N. College examination centre. Centre Superintendent confiscated the mobile and the FIR has been lodged with the police.

The Board has also proactively recommended to DGP to take strict action for negligence by the police personnel during frisking of candidates at duty point and arrest the candidate and her other accomplices. Taking swift action in the matter the candidate has been arrested and debarred from the current as well as future examinations conducted by the Board. Further, the accomplice of this candidate Mr. Sunny Dodum has also been arrested by the police. Police Department has suspended two police officials namely L/ct Geter Angu, 4th IRBN and L/ct Tage Munia, 1st AAPBn for failing to perform their duties. The Board hereby again advises all candidates to strictly observe the instruction of the Board while attending examination to avoid debarment or legal action.

In view of the above, the Board has decided to withhold the declaration of results pending report from the police.
