3. One vacancy under Sports Quota for Surveyor of Department of UD & Housing is not included in this result. The recruitment under Sports Quota shall be conducted in due course of time as per the Govt. norms and guidelines. However, these candidates are eligible to be considered for the remaining non-Sports Quota vacancies on the basis of merit.

4. The candidature of all the shortlisted candidates is PROVISIONAL subject to eligibility in all respects as prescribed in the Advertisement and Recruitment Rules. The candidates would be required to produce the original certificates in support of their Claim relating to age, educational qualifications, category etc.

5. The document verification for shortlisted candidates shall be conducted on 21.12.2021 (Tuesday) at the Office of APSSB, C-Sector, Itanagar from 10:30 hrs onwards.

6. Candidates must note that their Candidature is purely provisional at this stage and their

appointment will be subject to their name figuring in the provisional Select list which shall be prepared after the Document verification. Apart from that, they should fulfill the eligibility criteria as per Advertisement No. 08/2019 dated 18.12. 2019 and Corrigendum dated 19.12. 2019 including possession of the requisite documents, failing which their Candidature may be summarily rejected at any stage.

7. Further, the Appointing Authority i.e., the indenting/user department verifies the character and antecedents of the candidates, authenticity of documents/certificates and eligibility as per the Recruitment Rules before finally appointing the candidate(s). Therefore, the provisional shortlisting of a candidate does not confer upon him/her any right of appointment unless the Appointing Authority is satisfied, after such inquiry as may be considered necessary, that the candidate is suitable in all respects for appointment to the post.
