1. Schedule of written examination has been tentatively fixed on 18th & 19th September, 2021.
2. Details of registered candidates have been uploaded on the website www.apssb.nic.in.
3. Candidates are requested to verify their details. They can access their application by logging in to the website www.apssb.nic.in using their credentials (user id and password) w.e.f. 1100 hrs of 27/07/2021 to 1500 hrs of 16/08/2021.
4. During the period, only registered candidates are allowed to access their details and No NEW REGISTRATION SHALL BE ENTERTAINED.
5. Each registered candidate shall update their latest photograph and signature mandatorily during verification of details.
6. Candidates shall go through the guideline for up-dation of their data carefully. After final submission of updated data, no further up-dation shall be allowed and eligibility of the candidates shall be decided on the basis of finally submitted data.
7. Only those candidates who verify the details and whose details are complete in all respects would be eligible for issuance/downloading of admit cards.
8. Candidates may also note that incomplete application form not updated on or before 1500 hrs of 09/08/2021 and ineligible cases shall be summarily rejected. Such candidates will not be allowed to appear in the examination for respective posts.
